Goals and Objectives

Ekibastuzskaya GRES-1 named after Bulat Nurzhanov LLP for 2023 in the field of quality, environmental protection, health and safety, energy efficiency, anti-corruption and fraud

I. In the field of occupational health and safety

Purpose: To ensure the safety, preservation of health, efficiency of workers in the process of work:

- > Strengthen the role and responsibility of employees for the performance of key safety and health functions at all levels of relationships;
- To prevent group accidents and fatal accidents with employees of the Partnership and employees of contracting organizations;
- Take measures to contain the spread of COVID-19 coronavirus infection and similar viruses;
- Timely technical inspections, examination of technical devices to determine the possible duration of their further safe operation.

II. In the field of Combating corruption and fraud

Objective: To minimize the risk of involvement of officials and employees of the Partnership, regardless of their position, in corrupt and fraudulent activities:

To prevent the possibility of causes and conditions that contribute to the commission of corruption and fraudulent offenses.

III. In the field of Environmental protection

Goal: To minimize the level of environmental pollution:

- > Specific emission of pollutants not more than 11.23 g/1 kW*h;
- The specific volume of ash and slag waste is not more than 246.2 g/1 kW*h;
- Do not allow contamination of the station territory. Observe cleanliness and order in the fixed areas.
- Reclamation of the ash dump on an area of 30 hectares;
- ▶ Planting of trees on the border of the sanitary protection zone of at least 500 pieces;
- > Transfer of production and consumption waste to specialized enterprises for disposal/recycling/ disposal.

IV. In the field of Quality:

<u>Purpose</u>: To provide the consumer with an uninterrupted and reliable supply of electric energy:

- Ensuring the production of at least 22.15 billion kWh.;
- Do not exceed the coefficient of forced stops more than 4.2%;
- ➤ Do not exceed the number of technological violations (accidents, failures) 1.35 ost./billion.kWh, (30 technological violations).

V. In the field of Energy Saving:

Objective: To ensure the level of technical and economic indicators and economical consumption of energy resources:

- ➤ The specific consumption of conventional fuel is not more than 346.0 g/kWh;
- Electricity consumption for own needs no more than 4.69 %;

- ➤ The specific water consumption per GZU is not more than 2.0 m3/MWh.;
- ➤ Intra-station losses of steam and condensate no more than 0.85 %;
- ➤ The operating time of LDPE from the operating time of power units up to 80 %;
- > The operating time from the start of operation to the occurrence of the first failure is at least 2,800 hours.
